B Traffic regulations

To ensure a smooth flow of traffic on and in the vicinity of the exhibition grounds, special traffic regulations apply, which must be observed.

Please inform your set-up / dismantling team as well as your transport / freight forwarding service provider about these regulations!

1 Set-up and dismantling

- From motorway A 4, Eisenach-Ost exit (40 a), the approach is via the main road B 84 and the Kindel industrial zone. The route to the exhibition grounds is signposted.
- Delivery vehicles have access only via Gate West, where they must report to the information centre. Departure is only via Gate East.
- Stopping is absolutely prohibited along all of the approach and departure routes in the area surrounding the exhibition grounds. Exhibition management reserves the right to tow away vehicles parked on the routes or in the no-stopping area, at the expense of the vehicle owners.
- On the exhibition grounds, traffic is routed as one-way traffic.
- Throughout the exhibition grounds, traffic shall proceed at a walking pace. The German road traffic regulations (StVO) shall apply.
- Instructions of the traffic control personnel must be obeyed.

1.1 Last day of set-up

- On the last day of set-up, 22 June 2019, entry to the exhibition grounds is not permitted after 5.30 p.m.
- All vehicles must have left the exhibition grounds by 6.00 p.m.

1.2 First day of dismantling

- Vehicle access to the exhibition grounds via Industriestraße will be closed for lorries on 25 June 2019. Vehicles arriving for dismantling will be guided to an external parking area and parked there until access to the grounds is permitted.
- On 25 June 2019, entry will be permitted for transport vehicles up to 7.5 tonnes beginning at 7 p.m. Transport vehicles exceeding 7.5 tonnes can enter the exhibition grounds from 7 a.m. on Wednesday, 26 June 2019 onwards.

2 Vehicle traffic during the exhibition opening hours

During the exhibition opening hours, vehicle traffic is not permitted on the exhibition grounds.

3 Entry regulations for delivery vehicles during the exhibition

During the exhibition, deliveries to the stand areas are possible in the following time periods only:

- 23 June 2019 from 7.00 to 8.00 a.m. and from 6.30 to 7.00 p.m.
- 24 June 2019 from 7.00 to 8.00 a.m. and from 6.30 to 7.00 p.m.
- 25 June 2019 from 7.00 to 8.00 a.m.

Delivery vehicles will be permitted on the grounds after payment of a <u>deposit of €100,00</u> only. The deposit is to be paid in cash at the west entrance, and will be returned upon departure, if departure occurs on time.

4 Parking for cars and lorries

4.1 Long-term parking for transport vehicles

During demopark, transport vehicles can be parked free of charge.

There is a limited possibility of parking near the exhibition grounds.

All vehicles, with size information, must be registered by the exhibition management by 31 May 2019.

Beginning on 19 June 2019, the lorry parking permits can be picked up at the office of the exhibition management. The parking permits must be filled out with the exhibitor name, stand number, and mobile phone number. It must be placed clearly visible behind the windscreen of the vehicle.

4.2 Parking for cars

During the set-up and dismantling periods, parking area P2 will be available at the exhibition grounds.

During the exhibition, parking is free of charge for exhibitors and visitors. Cars can be parked at parking area P1 (west entrance), with access from the direction of Eisenach-Ost, or parking area P2 (entrances east and south), with access from the direction of Dresden (Exit Sättelstädt). The parking areas are clearly signposted.

At the time of the exhibition, exhibitors are requested to make an early decision regarding the approach to P1 via industrial area or the approach to P2 via Sättelstädt.
